EFFECTIVE AUGUST 1, 2005, ALL ILLINOIS COUNTY RECORDERS MUST COLLECT **\$10.00** FOR THE RENTAL HOUSING SUPPORT PROGRAM FUND STATE SURCHARGE FOR THE RECORDING OF ALL REAL ESTATE-RELATED DOCUMENTS.

Deeds and other instruments(REAL ESTATE-RELATED DOCUMENTS) \$56.00 for the first four pages plus \$1.00 for each additional page (THIS INCLUDES THE \$10.00 RENTAL HOUSING SUPPORT PROGRAM FUND STATE SURCHARGE). There is an additional charge of \$1.00 for each attachment to a page and each reference.

NON REAL ESTATE-RELATED FEE \$46.00 for the first four pages and \$1.00 for each additional page.

Recording maps of plats of additions or subdivisions, the fee is \$79.00 for the first four (4) pages and \$1.00 for each additional page. Plus \$12.00 for any document that is not 8 1/2"x11".
Recording fee for a financing Statement (UCC) is \$46.00. There is a \$5.00 fee for the Termination of a financing Statement. The fee to index a financing Statement in the mortgage record index is an additional \$10.00 for each name to be indexed.

The law that came into effect January 1, 1995 requires:

All documents are to be 8 1/2"x11". No permanently bond or continuous forms.

The document must be on white paper. The document must have clean margins of at least 1/2" all around. The first page of the document must have a blank space measuring 3"x5" in the upper right hand corner.

The cost for any document that does not conform to the new requirements is \$68.00 for the first four (4) pages plus \$1.00 for each additional page. These changes do not apply to UCC'S (Financing Statements).

EFFECTIVE JULY 1, 2011 MARRIAGE LICENSE \$38.00.

CIVIL UNION LICENSE \$38.00. EFFECTIVE JUNE 15, 2011.

REQUEST BY MAIL \$5.00 PER DOCUMENT UP TO 10 PAGES AND \$1.00 PER PAGE AFTER 10 PAGES.

FOR ALL REQUEST BY MAIL WE REQUIRE A SELF ADDRESSED STAMPED ENVELOPE.

ANY OVER PAYMENT RECEIVED IN THE MAIL OF \$5.00 OR LESS WILL NOT BE REFUNDED.
