The executor, administrator, guardian, petitioner, or other interested person or his or her attorney shall pay the cost of publication by the clerk directly to the newspaper.

The person on whose behalf a charge is incurred for witness, court reporter, appraiser, or other miscellaneous fee shall pay the same directly to the person entitled thereto.

The executor, administrator, guardian, petitioner, or other interested person or his or her attorney shall pay to the clerk all postage charges incurred by the clerk in mailing petitions, orders, notices, or other documents pursuant to the provisions of the Probate Act of 1975.

COURT APPEALS

Court appeals when original documents are forwarded under 100 pages, plus delivery and costs: **\$50.00**

Court appeals when original documents are forwarded over 100 pages, plus delivery and costs: **\$100.00**

Court appeals when original documents are forwarded over 200 pages- add'l fee per pg. **.25/per pg**

REPRODUCTIONS –

For reproduction of any document contained in the Clerk's files:

First page **\$2.00**

Next 19 pages, **.50/per pg.**

All remaining pages, **.25/per pg.**

HARD COPY PRINTOUT (when records maintained on automated system) **\$6.00**

EXEMPLIFICATION- (plus the fee of certification) **\$2.00**

CHANGE OF VENUE

For the filing of a change of case on a change of venue, the clerk shall be certified to the same fee as if it were the commencement of a new suit.

The fee for the preparation and certification of a record on a change of venue to another jurisdiction, when original documents are forwarded: **\$25.00**

CORRECTION OF NUMBERS **\$25.00**

For correction of the case number, case title, or attorney computer identification number, if required by rule of court, on any document filed in the clerk's office, to be charged against the party that filed the document:

MAILING

When the Clerk is required to mail, the fee will be: **\$10.00**

PETITION TO VACATE OR MODIFY final judgment or order (exceptions apply) **\$35.00**

(Exceptions include: Forcible entry and detainer case, small claims case, petition to reopen an estate, petition to modify, terminate or enforce a judgment or order for child or spousal support, or petition to modify, suspend or terminate and order for withholding.)

In a proceeding involving a motion to vacate or amend a final order, motion to vacate an exparte judgment, judgment of forfeiture, or “failure to appear” or “failure to comply” notices sent to the Secretary of State. **\$40.00**

RECORD SEARCH **\$6.00**

For each record search, within a division or municipal district, the Clerk shall be entitled to a search fee for each year searched.

NONSUFFICIENT FUNDS FEE- (*Check, draft or other bank document*) **\$25.00**

CHILD SUPPORT AND MAINTENANCE FEE: **\$36.00**

(*This is an annual payment paid by the person paying child support to offset the cost of maintaining child support records and processing.*)

Fee for Certification made to the Secretary of State- **\$5.00**

(*For reports made to Secretary of State re: non-payment of court ordered support or orders concerning driving privileges.*)
